Rules Governing the "Douglas Avenue Landscaping Grant"

- 1. Eligibility—Only existing commercial buildings within the Douglas Avenue Corridor boundaries will be considered. Tax exempt properties are not eligible.
- 2. Douglas Avenue Business Improvement District Board discretion—Applies in approving any grant.
- 3. Applications—Must be accompanied by current photograph of the building noting the proposed location of the landscaping and the type of landscaping to be installed. If a landscaping firm is being used a copy of the proposal including cost should be included.
- 4. No middleman role—Under no circumstances will the Douglas Avenue Business Improvement District Board be considered to be or act as the owner's agent or as part to any agreements or contracts associated with the Landscaping Grant project. The Douglas Avenue Business Improvement District Board will not have any role or responsibility in evaluating the compliance or application of any governmental codes relating to the proposed landscape installation.
- 5. Landscape Grant—The purpose of this grant is to provide assistance in the purchase and installation of enhanced or additional landscaping to beautify the Douglas Avenue corridor. It is the intention of the program to lead to actual installation of the proposed landscaping.
- 6. Payment of grant—Shall be made by Douglas Avenue Business Improvement District Board directly to the applicant upon submittal of a paid invoice and photographs of the completed project.
- 7. Approval void—Douglas Avenue Business Improvement District Board approval of Landscaping Grant is valid for 3 months only from the date of the Douglas Avenue Business Improvement District Board approval letter. If good faith undertaking of the installation has not occurred at the end of 3 months, the grant approval automatically becomes void.

 Re-application for the grant will be considered in such circumstances.
- 8. Total grant funding is limited to \$2,500.00. Properties are only eligible for funding every other year.
